

LEGAL BASES OF THE CALL FOR THE "*PRO-TRAINING*" PROGRAM FOR VOCATIONAL <u>TRAINING SCHOLARSHIPS 2023 OF THE FUNDACIÓN CEPSA</u> (CAMPO DE CRIPTANA)

<u>FIRST – PURPOSE</u>

FUNDACIÓN CEPSA with NIF G87612933 and domiciled in Madrid, at Paseo de la Castellana nº 259A, announces scholarships for students enrolled in the 2023/2024 academic year in Basic, Middle and Higher Vocational Training.

This scholarship program was created to promote access to this type of professional **training** as part of the Sumamos Energías program.

FUNDACIÓN CEPSA will award up to **TWO (2) scholarships in the amount of 2,500 euros each**. These scholarships are intended to finance the costs of education, such as tuition, school supplies, clothing or work uniforms, books, transportation and cafeteria service.

SECOND- REQUIREMENTS

Those who may apply for the vocational training scholarship program are:

- Students enrolled or pre-enrolled in the 2023/24 academic year in Basic, Middle or Higher Vocational Training. Enrollment in adapted VET studies or in specialization courses is also acceptable.
- The students registered in the town of Campo de Criptana
- Enrolled or pre-enrolled in one of the following Vocational Training families:
 - Electricity and Electronics
 - Energy and Water
 - Information Technology and Communications
 - Installation and maintenance
 - Safety and the Environment
- Students must have studied the previous year in Spain or the course must be approved by the Spanish educational authorities.
- Students must have been born between 1993 and 2008, both inclusive.

In the event that the person enrolled is a minor or is not legally emancipated, the application shall be submitted by his or her parents or guardians.

THIRD- SUBMISSION OF APPLICATIONS.-

Applications for this VET scholarship program should be submitted by sending an e-mail to proformacion@outsourcing.cepsa.com with the following documents:

- Scholarship application form according to the model provided by FUNDACIÓN CEPSA and included as Annex I of these Rules.
- Registration in Campo de Criptana.
- Copy of the DNI or NIE of the person enrolled and, if they're a minor or not legally emancipated, copy of the DNI or NIE of their parents or guardians, both sides.
- Certificate or document accrediting that the student is enrolled or pre-enrolled in the Basic, Intermediate or Higher Vocational Training center for the 2023/24 academic year. Both the application for the 2023/24 academic year, as long as it is stamped by the



educational center or registered by the Department of Education, and the certificate of enrollment are acceptable documents.

- Last income tax return of the applicant or, failing that, of the family unit of which he/she is a member. If any person in the family unit does not file an income tax return because they do not reach the minimum income figure, they must provide the draft income tax return prepared by the Tax Agency or the income certificate issued by the Tax Agency.
- Grades earned in the last academic year completed before 2023/24

In addition to the above documents, if the person enrolled is a minor, the following documents must be provided:

- A photocopy of the family book or documentation of guardianship of the minor.
- Copy of the DNI or NIE of the minor for whom the aid is requested, both sides.

In the event that the applicant meets any of the following circumstances, he/she must submit this documentation in addition to the previous one:

- In the case of large or single-parent families, proof of being a large or single-parent family.
- In the event that the applicant or his/her parents or guardians are unemployed, a certificate attesting to the unemployment situation.
- If the applicant has a recognized degree of disability or dependency, he/she must indicate it in the application and if he/she is finally selected, he/she must provide the certificate accrediting such disability or dependency at the time the scholarship is awarded.

The application for these scholarships will be compatible with access to other scholarships granted by public administrations or private entities.

FUNDACIÓN CEPSA will not process any application with an incomplete form. The application shall be null and void.

FOURTH - DEADLINES.

The submission period for applications and required documentation will run **from June 12**, **2023 to July 20**, **2023** at 6:00 p.m. (local time).

Applications will not be accepted after the established deadline.

FIFTH - EVALUATION OF APPLICATIONS.

The evaluation of the applications will be carried out by a Technical Secretariat and, once the applications that meet the requirements of these rules have been analyzed, an Evaluation Committee will select the final scholarship recipients. This Evaluation Committee will be appointed for this purpose by FUNDACIÓN CEPSA and will be open to the participation of the following:

- Representatives of the FUNDACIÓN CEPSA.
- Cepsa Gas y Electricidad representatives
- Experts in education.

The following criteria will be considered in selecting scholarship recipients:

- Income level, individual or family unit.



- Previous academic record.
- Cover letter.
- Accredited disability or dependency.
- Other socioeconomic circumstances such as being a large or single-parent family.
- The applicant or his/her parents or guardians are unemployed.

SIXTH - RESOLUTION and PAYMENT OF SCHOLARSHIPS.

The awarding of scholarships for vocational training studies will be resolved before September 15, 2023, TWO recipient students will be chosen for a scholarship amounting to TWO THOUSAND FIVE HUNDRED EUROS ($\leq 2,500$) each.

Once the resolution report has been issued, the beneficiaries of the scholarship will be informed through the e-mail address they have indicated in the personal data section in the scholarship request form.

The scholarships will be paid in two installments by bank transfer:

- 1st payment: ONE THOUSAND EUROS (1,000 euros) in the month of October 2023.
- 2nd payment: ONE THOUSAND FIVE HUNDRED EUROS (€1,500) in February 2024 upon submission of the first quarter evaluation grades.

FUNDACIÓN CEPSA reserves the right to cancel the second payment of the scholarship to those selected who do not provide their first quarter evaluation grades or if their academic performance is insufficient. Insufficient academic performance will be understood as failing more than 30% of the enrolled subjects.

FUNDACION CEPSA accepts that the scholarships will be used exclusively to cover educational expenses such as tuition, fees, tutoring classes, computer equipment, lunchroom expenses, books, school supplies, transportation to the educational center, or similar.

These grants are not intended to finance other expenses, such as health expenses (purchase of eyeglasses), driver's license, family meal expenses, housing expenses or supplies.

If the academic year ends and the beneficiary has not used all the aid, the remaining amount may be used for the payment of expenses for the following academic year, or for other training or complementary courses related to their education.

SEVENTH - OBLIGATIONS OF THE BENEFICIARIES

The beneficiaries of the grant must sign an agreement of acceptance of the FUNDACIÓN CEPSA scholarship, indicating the amount that has been granted and the obligations assumed by both parties.

The winners will be asked for a certificate of ownership of the bank account indicated to receive the scholarship, and it must be in the name of the applicant or, if the applicant is a minor, in the name of their parents or guardians.

In the event that any of the selected candidates rejects the scholarship awarded to him/her, or does not sign the acceptance agreement within fifteen (15) calendar days of being notified via e-mail, it will be understood that he/she rejects the scholarship and a new candidate will be selected.



In addition to the scholarship acceptance agreement, selected individuals must submit:

- In January 2024, first semester evaluation grades of the scholarship recipient.
- In July 2024, evaluation grades of the completed course and a final follow-up report according to a model to be provided by FUNDACIÓN CEPSA.

Fundación Cepsa will communicate with applicants through the email address provided on the application form. Failure to reply to notifications sent may result in the loss of the scholarship.

The beneficiaries of the aid must inform FUNDACIÓN CEPSA of any other scholarships obtained to pursue the same studies supported in this call for applications. FUNDACIÓN CEPSA must also be informed if the selected person decides to abandon his/her studies or if any extraordinary circumstance occurs that prevents or hinders his/her participation in the course in which he/she has enrolled.

EIGHTH - DATA PROTECTION

In accordance with the legislation on personal data protection, participants in the professional training scholarship program are informed that FUNDACIÓN CEPSA, as Data Controller, will process their personal identification, academic, family, economic and health data, in particular the degree of disability and, where appropriate, special educational needs, which are provided on the occasion of their participation in this program and will incorporate them into a record of processing activities owned by FUNDACIÓN CEPSA, with the following purposes:

- a) Manage their participation in the vocational training scholarship program;
- b) To process the awarding of scholarships to participants who are beneficiaries;
- c) Attend to any incidents that may arise in connection with participation in the scholarship program. A participant may be contacted if a suspected fraud or identity theft is detected.
- d) Communicate with the participant by telephone, e-mail or any other means of communication, in relation to his/her participation in the scholarship program and in particular to inform him/her whether or not he/she has been a beneficiary of the program.
- e) If consent is granted to this effect, the participant's personal data will be processed to capture and preserve his/her image and to carry out communication actions in order to disseminate the scholarship program in any corporate media, as well as on the platforms, channels and social networks in which FUNDACIÓN CEPSA has a page or profile of ownership.
- f) Fulfilling FUNDACIÓN CEPSA'S legal obligations.

With respect to the processing of health data concerning the Participant, such processing is carried out, in line with the above, for the purpose of enabling participation in this scholarship program. The basis of legitimacy, in accordance with Article 6 of the GDPR is the execution of the legal relationship arising from your participation, and the enabling circumstance for the processing of your health data, in accordance with Article 9 of the GDPR, is your explicit consent to that effect, given separately at the time of filling in your application for participation.

Participation in this call is voluntary, and if participating, it is warned that the treatment of the personal data of the participants and beneficiaries of this program will be carried out in the terms set out in the present Terms and Conditions. In this sense, for the proper development of the scholarship program it will be necessary for the personal data of the participants, as well as those provided for the delivery of the scholarship, to be true, complete and up to date, which



they undertake through the acceptance of these Terms and Conditions. If the personal data of a beneficiary of the scholarship program or third parties provided are uncertain, false, incomplete or not updated in such a way that the identification of the beneficiary is impossible by reasonable means, FUNDACIÓN CEPSA reserves the right to disqualify them from the scholarship program, being released from any liability in this regard. In case of providing personal data of minors, the Participant also declares to be their legal guardian or have sufficient legal representation to provide their personal data and consent to the treatments that, in each case, are allowed (for example, the treatment of the image for corporate dissemination purposes in FUNDACIÓN CEPSA channels and social networks, as well as for the treatment of the Participant's health data).
